

## NETVIGATOR Extra Service – Microsoft 365 Personal and Microsoft 365 Family Service (Digital download version) Terms and Conditions:

- 2. The Microsoft 365 Services may only be used by users in Hong Kong.
- 3. The Microsoft 365 Services are provided by Microsoft. To subscribe to the Microsoft 365 Services, you confirm to have read, understood and agreed to Microsoft's terms and conditions in relation to the Microsoft 365 Services.
